## Learning, Planning, and Agency Tuesdays 13:00 - 15:30

What does it mean to be is an agent? And what kind of control do we have over how our lives unfold? I'll try to guide us through a set of readings that will help us to examine the possibility that investigations in the cognitive and biological sciences will tell us something interesting about human agency. Some of the folks who we read will Skype in for discussion in the 14:30-15:30 block, and one will come as a visitor! (more on that as I work out all of the details).

## **Course Requirements:**

As with all of my seminars, this one will be writing intensive. You will each write a brief response to one of the readings each week; these papers will be no longer than 600 words in length, and they will be due by midnight on Monday. These papers can link ideas from the reading to other ideas you are working on; they can offer an objection to one of the arguments we are addressing; or they can attempt to extend an idea from the reading to a novel domain. To be quite frank, I don't care what you write about, as long as you show me that you are trying to make sense of the reading, and as long as you are trying to see what possibilities the readings afford.

Each seminar member will also write a short paper, which is no longer than 3000 words in length. This paper should address an argument or position that we discuss in the class, but it can do so in any way that could yield a paper that is submittable for a conference presentation. In past semesters, I have often worked with students to get these papers read to send out for a CFP, and I am happy to do so again this semester!

Finally, you will have the option of doing an individual presentation, or a group presentation. If you would like to do so, let me know, and we'll work out the details!

## Accessibility and diversity:

One finds a great deal of diversity in teaching and learning styles in a modern university.
